VENDOR RULES AND REGULATIONS

Exhibit Hours: Saturday, September 19, 2009
1 p.m. – 11 p.m.

No early exits.

Set-Up: Exhibitors will be responsible for all booth structures, set-up and furnishings; e.g. extension cords, signage, drapes, etc. Use only 30 amp/120 volt electricity. All food booths will need a fire extinguisher. Setup time is between 8:00 a.m. and 11:00 a.m. on Saturday, September 19. No early admittance. **Booths must be ready for City Inspectors by 11:00.** ALL VEHICLES must be out of the Park by 12 Noon. Booths must be open by 1 p.m.

Tear-Down: Participants are responsible for dismantling their booths and cleaning booth space before leaving.

Booth Placement: Will be at the sole discretion of the Committee.

Music: No “boom” boxes or recorded music is allowed in the booth areas.

Roaming and Selling: No roaming vendors allowed. Sales and activities are limited to those who have purchased a booth.

Liability: No participant will be allowed to set up without a signed and dated application and release of liability. The Committee reserves the right to revoke or refuse to grant space at any time, without recourse by the participant. The Committee shall not be liable to anyone for this action.

Refunds: No fees shall be refunded. Inclement weather will not be grounds for refund. No early exits.

Exclusive Rights: No exclusive rights for the sale of any item will be granted to vendors. *The Denton Black Chamber of Commerce has exclusive sales of all beverages, including but not limited to, soft drinks, bottled water, and alcoholic beverages.*

BOOTH FEES

Space is limited. Booths are assigned on a first-come, first served basis. The City of Denton requires a Vendor Permit for any booth selling items (the fee for the Vendor Permit is included in the Booth price). A Food Handler’s Permit is also required for Food vendors. (Note: This is in addition to the Vendor Permit).

The Denton Black Chamber of Commerce reserves the right to limit food & drink items sold at the event. **The Denton Black Chamber of Commerce has exclusive sales of all beverages, including but not limited to, soft drinks, bottled water, and alcoholic beverages.**
